

Privacy Policy As of 02.3.2018

Protecting your private information is our priority. This Statement of Privacy applies to <https://drugtestingcourses.com> and Easler Education Inc. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Easler Education Inc. include <https://drugtestingcourses.com>, Easler, <https://drugtestingpolicy.com>, and <https://drugtestingsupplies.com>. The Easler website is a news, information, e-commerce drug testing courses and supplies site. By using the Easler website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Easler may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title

If you purchase Easler's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Easler may also collect anonymous demographic information, which is not unique to you, such as your:

We do not collect any personal information about you unless you voluntarily provide it to us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Easler collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Easler may also use your personally identifiable information to inform you of other products or services available from Easler and its affiliates.

Sharing Information with Third Parties

Easler does not sell, rent or lease its customer lists to third parties.

Easler may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. Tracking User Behavior

This data is used to deliver customized content and advertising within Easler to customers whose behavior indicates that they are interested in a particular subject area.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Easler. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Easler website.

Use of Cookies

The Easler website may use “cookies” to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server.
